

**VISA REQUIREMENTS**

The visa application is processed in 7 working days. Normal processing charges applicable for this visa.

The Urgent visa, will be processing in minimum of 3 working days. All visas issued with urgency are subject to an additional tax.

**EMOLUMENTS TABLE IN ATTACHED**

**ATT. DO NOT MAKE PAYMENT BEFORE THE AUTHORIZATION**

- Request for a visa before departure
- The release time is 7 working days
- The time for issuing visas with urgency is 3 working days.
- Any payment made to the embassy will not be refunded.
- Vaccinations are not mandatory (Only Yellow Fever if coming from countries affected – See attached).
- For children: travel authorization with the declaration of responsibility, countersigned by parents with original passports attached and photocopy of the same. If traveling with only one parent, it must also submit the extract of birth certificate, recognized by the Prefecture.
- The shipping costs are borne by the applicant as well as reservations at the couriers, recalling that the Embassy will not be liable for any delay or loss, and deliveries are made exclusively for express delivery.
- Multiple entry visas of 180 days cannot be issued, except for reason of study, with full and appropriate documentation.

All documents issued in a matter of urgency are subject to an additional tax .

- For all kinds of action: it will be necessary to attach the bank receipt of the payment, upon request of the consular service - (Any payment made in favor of the Embassy will not be refunded).

*General Documents for visa Requirements to Enter the Republic of Mozambique*

- Applicants must submit the original passport that must be valid for at least six (6) months from date of submission and have at least Three (3) blank page for visa stamp (amendment pages are not acceptable);
- Photocopy of passport
- Fill-out one (1) application form
- Two(2) photographs
- airline tickets ( also return ticket is needed)
- booking Hotel
- the receipt of payment made by bank transfer
- Holders of passport other than Italian are requested to present a copy of their resident card in Italy
- Some nationalities, for issue a visa, must wait the authorization of the immigration authorities

- **When sending documents by courier or by mail it must be attached a cover letter presenting the documents, with the specifications for the return (Address Nr. Telephone and freight).**

***Business/visit's Visas: "G"***

- Single entry: valid for two (2) months and a stay of thirty (30) days (can be extended up to ninety (90) days )
- Double entry: valid for two (2) months and a stay of up to thirty (30) days each entry )
- Multiple entry: valid for three (3) months - It allows to stay from 10 to 30 days per each entry –
- If requesting for a visitor's visa, the name and address of the person to be visited in Mozambique should be written on the application form. It should be attached a letter of invitation and term of responsibility for your stay, legalized by the Mozambican authorities and a copy of the identity document issued by the Mozambican authorities

***Tourist's Visas: "E"***

- Single entry: valid for two (2) months and a stay from thirty (30) to ninety (90) days
- Double entry: valid for two (2) months and a stay of up to thirty (30) days each entry Multiple entry: valid for three (3) months - It allows to stay from 10 to 30 days per each entry –
- If requesting for a tourism visa, the hotel reservation should be attached;

***Business/Working Visas: "H"*** –Single entry: valid for two (2) months and a stay of thirty (30)

If requesting for a business visa "H", a letter from the applicant's company is required;

***Residence/Working Visas: "J - D"***

Single entry: valid for two (2) months and a stay of thirty (30) days to process the residence permit (D.I.R.E.)

VISA – D OR J - FOR RESIDENCE - E - PERMANENT JOB (Allowing you to take the "DIRE" at the migration offices in Mozambique):

- If requesting for a working visa “J” you must also submit the following documents:,
  - a working contract (registered by the Mozambican Ministry of Work )
  - authorization of the Ministry of Work under quotas
  - Official letter from the company based in Mozambique, which will require an entry in the country, specifying the type of visa requested and where it guarantees for the entire stay (medical expenses, accommodation and repatriation) of the worker.
  - criminal record (faithful translated and recognized by competent authorities
    - for persons not resident in Italy, the criminal record translated into English or in Portuguese, must be recognized by the Ministry of Foreign Affairs of the country of origin and the respective Embassy accredited in Italy to be attached to the application;
  - for persons not resident in Italy, you must have the permission of the National Directorate of Migration of Mozambique

It is important that all stamps are readable

FOR ONG’s

- Letter of the Company's liability, NGOs or Affiliation, found in Mozambique by the Competent Institutions.
- Original criminal record, legalized by the Judicial Prosecutor or the Deputy Prosecutor (it also can be translated and legalized c / o our Embassy
- Work contract legalized by the National / Provincial Labour in Mozambique and the Ministry of Foreign Affairs and Cooperation in Mozambique (MINEC).  
Company Documents

NGOs, must also submit the authorization issued by the biennial MINEC

For the Religious, the Ministry of Justice - Directorate of Religious Affairs and the Office of Migration, must legalize a letter of responsibility and request for a visa with the right to residence

#### ***Transit Visas:***

- Single entry: valid for two (2) months with a maximum stay of seven (7) Double entry: valid for two (2) months with a maximum stay of seven (7) days per entry
- If requesting for a transit visa, the applicant must have the visa for the final destination;

**All applicants should write their residence address and phone number on the application form; including the receipt of payment made by bank transfer**

***The embassy disclaims any responsibility ( all persons not resident in Italy must take care of sending documents and the returned of them, booking the courier and sending an email at the embassy communicating the reservation number )***

***Citizens of the European Union where there is not Diplomatic Representation, can obtain a visa upon arrival directly at the entry border in Mozambique***

## FEBBRE GIALLA

Os viajantes que residem ou que tenham passado por um dos 43 países tidos como estando a braços com a febre amarela devem apresentar obrigatoriamente um certificado de vacinação ou documento equivalente ao entrarem em Moçambique. O viajante que não apresentar o certificado poderá ser vacinado no ponto de entrada, mediante o pagamento do valor de 1.350 meticias.

Para aqueles viajantes que tenham transitado por qualquer um desses países, desde que tenham deixado as instalações do aeroporto dos referidos países, também ser-lhes exigido o certificado de vacinação em cumprimento do Diploma Ministerial n° 236/2009 de 14 de Outubro.

Os 43 países abrangidos são:

Angola, Benin, Bolívia, Brasil, Burquina Faso, Burundi, Camarões, Chade, Colômbia, Congo, Costa do Marfim, Equador, Etiópia, Polinésia, Gabão, Gâmbia, Gana, Guiana, Guiné-Conacry, Guiné-Bissau, Guiné Equatorial, Libéria, Mali, Mauritânia, Níger, Nigéria, Panamá, Perú, Quénia, República Centro Africana, RDCongo, Ruanda, Somália, São Tomé e Príncipe, Senegal, Serra Leoa, Sudão, Suriname, Tanzania, Togo, Trinidad e Tobago, Uganda e Venezuela.

## TRADUZIONE

I viaggiatori che risiedono oppure passati per uno de 43 Paesi sotto elencati, devono obbligatoriamente presentare all'entrata un certificato di vaccinazione o documento equivalente.

Il viaggiatore che non presenta il certificato, potrà essere vaccinato al punto di entrata, mediante il pagamento del valore di 1.350,00 meticais.

Per i viaggiatori che transitano in uno di questi paesi, a condizione che abbiano lasciato le strutture aeroportuali, sarà richiesto il certificato delle vaccinazioni in conformità del Diploma Ministeriale n° 236/2009 del 14 Ottobre
